■ Evaluation for Korean language course

- 1st: Documentation review
- 2nd: Interview (Interview will be done online)
- Standard for students with tied scores: All students with tied scores will be selected
- If the submitted documents are missing or there are false facts, they will be excluded from the selection process

■ Admission procedures for Korean language course

- Submit application form&application fee to International Affairs Team → Screening process → Successful applicants receive confirmation → Issue confirmation of admission letter → Apply for Korean visa at Korean embassy(consulate) → Successful applicants remit to designated account → Entry within the specified period
